**Description:** Bottom licenses are durable cards with magnetic stripe and bar code on back. Top license is laminated; position of data fields may vary. For CDL, brown (bottom licenses) or red (top license) "COMMERCIAL DRIVER LICENSE."

**Minor's license:** Current license is in vertical format with red "UNDER 21 DRIVER LICENSE" and red "UNDER 21 UNTIL (date)" at top. Middle license has photo on left with same words as above. Drivers under 18 are "PROVISIONAL" shown by purple print. Top license has "UNDER 21" in red phantom letters. Drivers under 18 have 45° profile photo. "PROVISIONAL."

State plans to issue a new license in 2008.

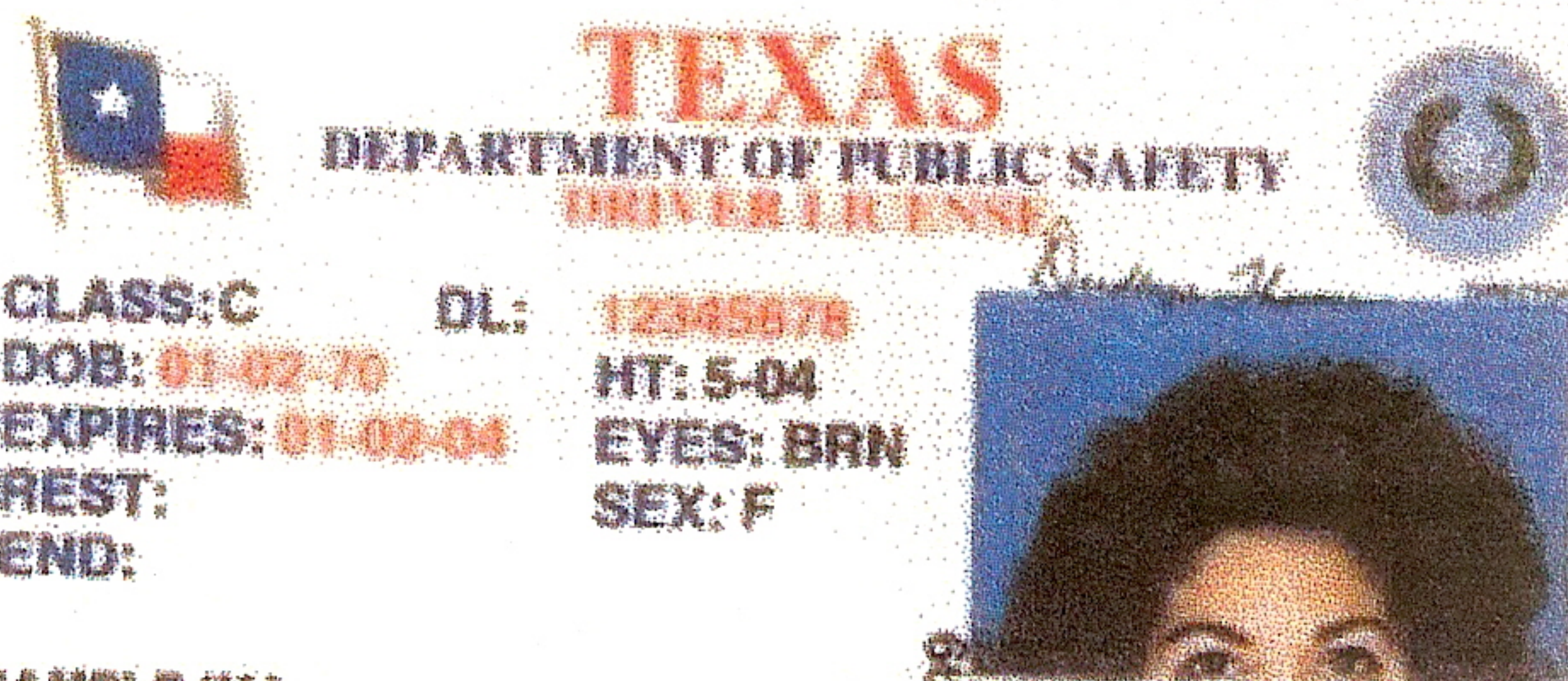
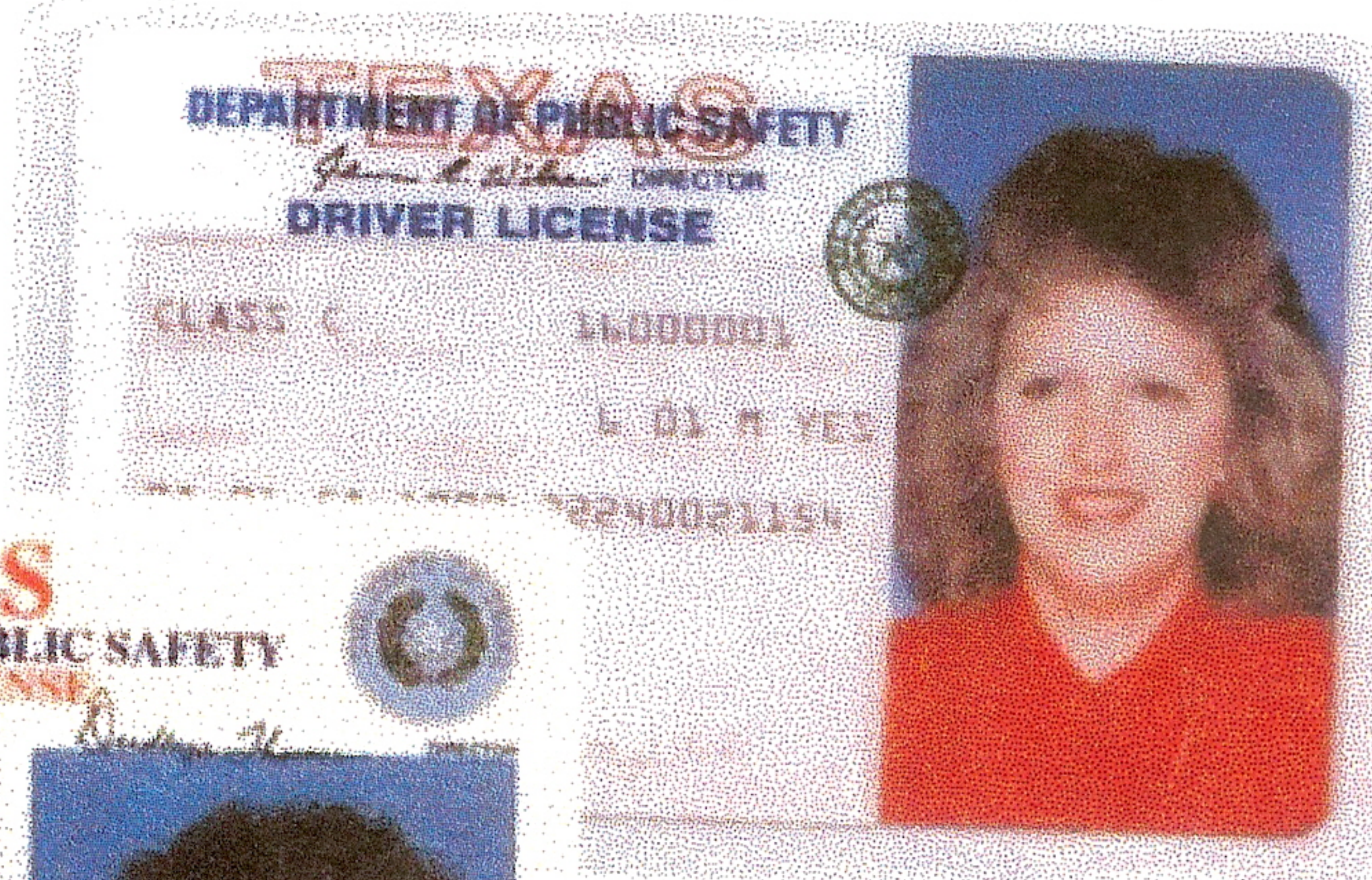
**Validation:** Bottom licenses have security laminate repeating "TEXAS" in metallic ink that is visible under UV light; director's signature and audit number around photo; micro-printing. Top license has state seal embedded in laminate; state seal overlaps photo; director's signature.

**Number:** 8 digits, unspaced, unencoded.

**Term:** 4, 5, or 6 years, expiring on birthday; may be extended for up to 6 years, once only. Early renewal option allows for renewal 1 year prior to expiration date. Under 18 drivers have 1- and 2-year terms expiring on next birthday. As of September 2005, 5 years for CDL. Photo update required every 12 years.
